FOR HYDROCARBON REFRIGERATION UNITS

WARNING

This unit uses R-290 (propane), or R-600a (isobutane) as a refrigerant. These hydrocarbon refrigerants are highly environmentally compatible but also are flammable and combustible. Please read this manual thoroughly before installing and operating the unit. Please take cautious measures to avoid risk of fire or explosion.

PLEASE REFER TO THE LABEL INSIDE THE CABINET TO CHECK REFRIGERATION TYPE AND VOLUME.

DANGER - Risk of fire or explosion. Flammable refrigerant used. Do not use mechanical devices to defrost refrigerator. Do not puncture refrigerant tubing.
DANGER - Risk of fire or explosion. Flammable refrigerant used. To be repaired only by trained service personnel. Do not puncture refrigerant tubing.
DANGER - Risk of fire or explosion. Flammable refrigerant used. Consult repair manual/owner's guide before attempting to service this product. All safety precautions must be followed

Do not use electrical appliances inside the food storage compartments of the appliance, unless they are of a type recommended by the manufacturer.

FOR HYDROCARBON REFRIGERATION UNITS

WARNING

- Handle the unit with care in order to avoid any serious damages to the refrigeration system.
- The refrigerant tubing, condenser, evaporator coils are easily prone to damage while handling, moving, installing, and cleaning the unit, which may lead to fire or even explosion.
- Refrigerant squirting out of the pipes could ignite or cause an eye injury. If a leak is detected, avoid any open flames or potential sources of ignition and air out the room in which the appliance is standing for several minutes.
- In order to avoid the creation of a flammable gas-air mixture in case of a leak in the refrigerating circuit, the size of the room in which the appliance is placed depends on the amount of refrigerant used. The room must be 35.31*ft*³ (1*m*³) in size for every 0.28*oz* (8*g*) of R-600a and 0.25*oz* (7*g*) of R-290 refrigerant inside the appliance. The amount of refrigerant in your particular appliance is shown on the label inside the cabinet. The refrigerant charge of a flammable refrigerant in a self-contained appliance used in a public corridor or lobby shall not exceed 3 m³ x LFL. (R-290 : 114 g / R-600a : 129 g)



This appliance contains a small amount of propane (R-290) or isobutane (R-600a) refrigerant, a natural gas with high environmental compatibility, but it is also combustible. When transporting and installing the appliance, care should be taken to ensure that no part of the refrigerating circuit are damaged.

- Never start up an appliance showing any signs of damage. When in doubt, contact a qualified service professional.
- In case of any hazardous activities such as fire or explosion, move the unit away from any source of ignition to a well ventilated area.
- Further service and repair must be done by a qualified technician who is familiar with the safety standards, and also has thorough understanding and knowledge of the flammable refrigerants.
- Any and all technicians handling these units must be equipped with proper personal protection and equipment and follow applicable safety measures and precaution to avoid risk of fire or explosion.

SAFETY PRECAUTIONS

To avoid any risk of fire, explosion, electric shock, personal injury, material damage or incorrect use of the appliance, be sure to observe the following safety precautions. (After reading these owner's manual instructions, please keep the manual booklet in a safe place for reference. Remember to hand it over to any subsequent owners)

WARNING

- The unit must be installed and located in accordance with the manufacturer's installation instructions.
- Installation work must be performed in accordance with the National Electric Code by qualified and authorized personnel only.
- Repairs and replacement work must be performed by a qualified and authorized service professionals only using genuine replacement part. If the SUPPLY CORD is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.
- Do not use an extension cord or an adapter plug. Because of the potential safety hazards under certain conditions, we strongly disrecommend any use of an extension cord or an adapter plug.
- Do not, under any circumstances, cut or remove the ground prong from the power cord. For personal safety, this appliance must be properly grounded.
- Do not store volatile and flammable substances in the refrigerator. The storage of benzene, thinner, alcohol, ether, LP gas, or other explosive substances may cause an explosion.
- Do not store or use gasoline or other flammable vapors and liquids in the vicinity of this appliance as well as any other appliances.
- The appliance is not intended for use by children without supervision.
- Do not allow children to climb, stand, or hang on the refrigerator doors or shelves in the refrigerators. They could damage the refrigerator and seriously injure themselves.
- To prevent suffocation and entrapment hazards of children, remove the doors and seals from the refrigerator before disposing of it or discontinuing its use.

INSTALLATION & USAGE

WARNING

- Do not install the unit in a damp place where it could be splashed with water. Incorrect insulation of the electrical parts may cause fire or electric shock.
- Do not plug several appliances into the same sockets. This could cause overheating and risk start of a fire.
- Keep the power plug away from the rear of the cabinet. A damaged power plug may cause fire due to overheating.
- Do not spray water directly to the interior or exterior of the appliance. There is a risk of fire or electric shock.
- Do not place any containers filled with water on top of the appliance. If the water spills onto any electrical parts, it may lead to fire or electric shock.
- Do not attempt to repair, disassemble or alter the appliance. It may cause fire or abnormal operations which may lead to injury.
- Unplug the refrigerator before making repairs, replacing a light bulb, or cleaning.
- Plug into a grounded 3-prong outlet. Do not remove the ground prong.

- Do not store too much food in the appliance. When you open the door, an item may fall out and cause personal injury or material damage.
- Do not put bottles or any kind of glass in the freezer. The container may break and cause personal injury.
- Do not disconnect the power cord by pulling on it. This may disconnect a wire and cause a short circuit.

INSTALLATION & USAGE

- There is a risk of death from suffocation if a child puts the packing materials on his or her head.
- Do not store any articles on top of the appliance. Articles may fall while opening or closing the door, and could cause personal injury or material damage.
- Do not store pharmaceutical products, scientific materials or other temperature-sensitive products in the refrigerator. Products that require strict temperature controls must not be stored in the refrigerator.
- Do not let children hang on the door.
- Do not touch any cold surfaces or food containers in the freezer with damp or wet hands. Skin may stick to these extremely cold surfaces and may cause frostbite.
- Remove any foreign matter from the power plug pins. Otherwise, there is a risk of fire.
- Do not insert your hand into the bottom area of appliance. Any sharp edges may cause personal injury.
- After unplugging the appliance, wait at least five minutes before plugging it back in. Abnormal operation of the freezer may cause material damage.
- If the appliance is not used for a long period of time, unplug it from the power supply. Any deterioration in the insulation may cause fire.
- Do not let children touch or play with the control panel on the front of the appliance.
 - Do not allow children to play with this appliance.
 - Do not stand or lean on the base panel, pull-out parts, or doors.
 - Repairs and maintenance of the appliance should only be performed by a qualified technician. Incorrect repairs done by an unqualified person may be a potential source of danger that could have critical consequences for the user of the appliance.
 - Never put ice cubes or ice lollies straight from the freezer into your mouth. The low temperature may cause cold burns.

PROPER DISPOSAL OF OLD APPLIANCE

For environmental purpose, refrigeration appliances must be disposed of properly. This applies to your old appliance, and at the end of its service life, for your new appliance as well.

WARNING

Before disposing of old appliances, make them inoperable. Remove plug from mains, severe the power cable, and remove or destroy any snap or latch closures. This eliminates the danger of any children locking themselves into the appliance (danger of suffocation) or placing themselves into other life-threatening situations.

- The appliance may not be disposed of with domestic waste or bulky refuse.
- The refrigerant circuit, especially the heat exchanger at the back of the appliance, may not be damaged.
- Information concerning collection schedules or locations can be obtained from the local disposal authorities.

The refrigeration used in refrigerator/freezer and the gases in the insulation material requires special disposal procedures. Ensure that none of the pipes on the back of the appliance are damaged prior to disposal.

BEFORE YOU CALL FOR SERVICE

Before contacting our Service Department, review the detailed troubleshooting tips in the Owner's manual.

- 1. Try to remedy the problem. Please read the "Troubleshooting Guide" section first and you may not need to call for service.
- 2. Restart the appliance to check whether the fault repeats. If the malfunction persists, switch off the appliance and try again after an hour.
- 3. If the malfunction still persists, then contact our Customer Service, specifying:
 - The nature of the problem,
 - The appliance model number and serial number
 - Your full address, telephone number and area code.









DRAFT ARMS TOWERS INSTALLATION SCHEMATIC DIAGRAM




* Assemble DRAFT TOWER as indicated in the above diagram.

* Assemble BEER LINE & CO2 LINE as indicated in the above diagram.


BEER LINE & CO2 LINE INSTALLATION SCHEMATIC DIAGRAM



IMPORTANT CAUTIONS



Don't pull out or turn drain line.

IMPORTANT CAUTIONS



- Opening the doors excessively may cause breakdown.
- When closing the door, handle with care.

1. POWER CORD

- Be sure the power cord is connected to the proper voltage. Make sure the amps are running before connecting the power cord to the outlet.
- A protected and dedicated circuit with the correct voltage and amperage must be running in order to have connection to the line cord.
- Whenever cleaning or performing maintenance on the unit, unplug the power source first.
- Warranty will be void if anything is damaged due to being plugged into improper voltage.

2. RE-STARTING


- If unplugged, wait 5 minutes before re-starting.

3. POSITIONING DRINKS

- Do not obstruct the air inlet which is located at the back inside of the unit.
- 4. To prevent a child from being entrapped, keep out of reach of children and not in the vicinity of the freezer.
- 5. Never repair or disassemble or amend the cabinet on your own.
 - There is a risk of person injury or damage to the freezer.
 - It is recommended that any service be carried out by a qualified person.

INSTALLATION OF THE BOTTOM SHELVES (BOTTLE COOLER)

- 1) Before adding cans or bottles to cooler, bottom shelves must be installed.
- 2) Install dividers after bottom shelves are installed. (see next page)




* Note:

The size and quantities of bottom shelves may be different according to the model number.

INSTALLATION OF DIVIDERS (BOTTLE COOLER)

- 1) To re-position dividers, push backwards.
- 2) Spring located at point 'C' will be shorten to about 1/2 inch.
- 3) Front of divider will be able to remove from point 'A' and 'B'.
- 4) Position divider in the hole, point 'C' where you would like it.
- 5) Push divider backwards.
- 6) Insert front of divider in the holes, point 'A' and 'B', where you would like it.


The shape and quantities of the dividers can be different according to the model number.

INSTALLATION OF THE OPENER KIT (BOTTLE COOLER)

- 1) In mounting the bottle opener kit located inside the cabinet, use the screws, locating on the front of the bottle cooler.
- 2) Hook the opener kit onto the screws as shown in drawing ① and then slide down the mounting with the hollow as shown in drawing ②.


Check and see if the bottle opener kit is securely mounted so as to prevent dislodging through vibration.

3) To detach, follow the above list in reverse.



HOW TO USE THE BOTTLE OPENER (BOTTLE COOLER)

- 1. Insert the bottle cap inwards as shown in diagram.
- 2. Grip the bottle tightly so it will not fall while removing cap.
- 3. The cap will drop to the bottom of the opener case.
- 4. When the opener case is full, separate from a cabinet.
- 5. Turn the opener case over to empty.





NOTICE TO CUSTOMER

Loss or spoilage of products in your refrigerator/freezer is not covered by warranty. In addition to following recommended installation procedures, you must run the refrigerator/ freezer 24 hours prior to usage.

INSTALLATION

- **1. LOCATION -** Allow adequate space and install the refrigerator on a firm, and level floor. If the appliance is not level, there may be unusual noises and poor cooling performance.
- 2. GOOD AIR CIRCULATION Be sure to avoid any partition and object which may stop the air flow and that air space is allowed to flow to the rear and/or sides of the unit between the refrigerator and the back wall. Insufficient space causes vibration noise, inefficient refrigeration, damage to the refrigeration system, and the waste of electricity. (RefrigerationX recommends that the rear of the unit should be no less than 5 inches from the wall)
- **3. PLACE ON STRONG FLOOR -** Be sure that the floor of which the unit is to be installed is strong enough to support the total weight of the cabinet and any other contents, before starting the installation.
- **4. DO NOT PLACE NEAR HEAT -** Be sure to avoid hot corners and other locations such as near stoves. High ambient temperature will make much lower cooling efficiency.
- 5. INDOOR USAGE ONLY Be sure to install this unit indoor only. It should prohibit getting wet from the rain.
 Do not install the refrigerator in locations where the temperature is over 100°F (38°C) or below 50°F (10°C).
- **6. STABILIZING -** Make sure the unit is installed in a stable condition with the front wheels locked while in use.
- 7. LEVELING Be sure that the unit levels from the front to the back and side to side.
- **8. UNIT SHOULD BE ON DEDICATED OUTLET -** Plug the refrigerator into a wall socket exclusively for this appliance. Do not run on extension cord.

9. THE ELECTRICAL PLUG MUST BE ACCESSIBLE WITHOUT MOVING THE UNIT.

10. IF A FOOD STORAGE IS IN POSITION, A MAXIMUM OF ONE SHELF MAY BE LOADED LESS THAN 110*lb* (50*kg*), BUT DO NOT ALLOW LOADS TO OVERHANG FROM THE FRONT AND REAR EDGES OF SHELVES (only for model XBB, XBC series).

CLEANING

Before cleaning, unplug the unit and disconnect the power. Wipe and clean the inside and outside of appliance with a damp cloth.

1. CLEANING THE INTERIOR AND EXTERIOR

- The interior and exterior of the unit can be cleaned using warm water with soap.
- Do not use an abrasive cleaner because it will scratch the surface.


2. CLEANING THE CONDENSER COIL

- To maintain proper refrigeration performance, the Condenser coil must be free of dust, dirt, and grease. This will require periodic cleaning. Condenser coil should be cleaned at least every three months (90 days) or as needed.
- To clean the condenser, unplug the power cord. Condenser can be cleaned with vacuum, brush, or CO2 (high pressure air).
- **NOTE:** For a self-cleaning condenser equipped model, condenser cleaning is not required.

However, it is recommended to blow the condenser coil out with Nitrogen once or twice a year. Note that the condenser cleaner may not remove grease.

3. CLEANING THE WIRE NET

- Remove the screw from the WIRE NET by unscrewing the factory-installed screw, and carefully clean off any accumulated dirt or dust. After cleaning, reinstall the WIRE NET by tightening all the screws.



4. CLEAN THE DRAIN PAN


- Periodically, empty the drain pan which is located under the unit.
- When reinstalling the Drain Pan, make sure the drain hose is placed back into the pan.

5. CHECK AFTER CLEANING

- 1) Check the unit again for safety.
- 2) Plug unit back in and turn on power switch.
- 3) Check that the unit is operating properly.

BASIC OPERATION

- 1. The controller(thermostat) is located at the right inside of the unit.
- 2. The factory setting for the control is '4', and maintains about 38°F (3°C) inside.
- 3. Set toward "1" for warmer temperature and "7" for colder temperature.

4. The thermostat controls compressor's cycling by sensing temperature inside the unit.



STAINLESS STEEL EQUIPMENT CARE AND CLEANING



CAUTION : Do not use any steel wool, abrasive or chlorine based products to clean stainless steel surfaces.

Stainless Steel Opponents

There are three basic things which can break down your stainless steel's passivity layer and allow corrosion to rear its ugly head.

- 1) Scratches from wire brushes, scrapers, and steel pads are just a few examples of items that can be abrasive to the stainless steel surface.
- 2) Deposits left on your stainless steel can leave spots. You may have hard or soft water depending on what part of the country you live in. Hard water can leave spots. Hard water that is heated can leave deposits if left to sit too long. These deposits can cause the passive layer to break down and rust your stainless steel. All deposits left from food prep or service should be removed as soon as possible.
- 3) Chlorides are present in table salt, food, and water. Household and industrial cleaners are the worst type of chlorides to use.

8 steps that can help prevent rust on stainless steel:

1. Using the correct cleaning tools

Use non-abrasive tools when cleaning your stainless steel products. The stainless steel's passive layer will not be harmed by soft cloths and plastic scouring pads. Step 2 tells you how to find the polishing marks.

2. Cleaning along the polish lines

Polishing lines or "grain" are visible on some stainless steels. Always scrub parallel to visible lines on some stainless steels. Use a plastic scouring pad or soft cloth when you cannot see the grain.

3. Use alkaline, alkaline chlorinated or non-chloride containing cleaners

While many traditional cleaners are loaded with chlorides, the industry is providing an ever increasing choice of non-chloride cleaners. If you are not sure of your cleaners chloride content contact your cleaner supplier and request a non-chloride cleaner that can be used as alternative to chloride containing cleaners. Avoid cleaners containing quaternary salts as they can attack stainless steel, causing pitting and rusting.

4. Water Treatment

To reduce deposits, soften the hard water when possible. Installation of certain filters can remove corrosive and distasteful elements. Salts in properly maintained water softener can be to your advantage. Contact a treatment specialist if you are not sure of the proper water treatment.

5. Maintaining the cleanliness of your food equipment

Use cleaners at recommended strength (alkaline, alkaline chlorinated or nonchloride). Avoid build-up of hard stains by cleaning too frequently. When boiling water with your stainless steel equipment, the single most likely cause of damage is chlorides in the water. Heating any cleaners containing chlorides will have the same damaging effects.

6. Rinse

When using chlorinated cleaners you must rinse and wipe dry immediately. It is better to wipe standing cleaning agents and water as soon as possible. Allow the stainless steel equipment to air dry. Oxygen helps maintain the passivity film on stainless steel.

7. Hydrochloric acid (muriatic acid) should never be used on stainless steel.

8. Regularly restore/passivate stainless steel.

Recommended cleaners for certain situation/environments of stainless steel.

- A) Soap, ammonia and detergent medallion applied with a cloth or sponge can be used for routine cleaning.
- B) Arcal 20, Lac-O-Nu Ecoshine applied provides barrier film for fingerprints and smears.
- C) Cameo, Talc, Zud First Impression is applied by rubbing in the direction of the polished lines for stubborn stains and discoloring.
- D) Easy-off and De-Grease it oven aid are excellent for removals on all finishes for grease-fatty acids, blood and burnt-on foods.
- E) Use any good commercial detergent with a sponge or cloth to remove grease and oil.
- F) Benefit, Super Sheen, Sheila Shine are good for restoration/passivation.

TROUBLESHOOTING

- 1. If the appliance does not turn on, check for:
 - Power failure,
 - Properly inserted plug,
 - The power switch is on,
 - Thermostat setting
- 2. If the temperature inside the compartments is not low enough, check for:
 - Closure of the doors,
 - Installation near a heat source,
 - Correct setting of the refrigerator / freezer temperature controls,
 - Inhibited air circulation.
 - Condenser coil is properly cleaned.
- 3. If the refrigerator compartment temperature is too low, check for:
 - Correct setting of the temperature controls.

The following points are not malfunctions:

- A water-flowing sound can be heard when the compressor stops. This is the sound of REFRIGERANT flowing.
- The compressor does not run during the defrost cycle.

Note: Formation of condensation on and around the edge of the door and the front side of the cabinet is normal. Gurgling noises inside the refrigerating circuit are normal.

TWO (2) YEAR WARRANTY

Warranty Claims...

All claims for parts or labor must be made directly through RefrigerationX. All claims should include: model number of the unit, the serial number of the cabinet, proof of purchase, date of installation, and all pertinent information supporting the alleged defect. In case of compressor replacement under warranty, either compressor or compressor tag must be returned to RefrigerationX along with above listed information.

Failure to comply with warranty policies will result in voiding claims.

Limited Warranty

"On-site warranty service calls <u>within 70 miles of an authorized service company in fifty states of the United States.</u> End user is responsible for all extra travel and mileage at prevailing rates. No mileage or travel time is paid."

Two-Year Parts & Labor Warranty...

RefrigerationX warrants all new refrigerated components, the cabinet and all parts, to be free from defects in materials or workmanship, under normal and proper use and maintenance service as specified by RefrigerationX and upon proper installation* (indoor building only) and start-up in accordance with the instruction packet supplied with each RefrigerationX unit. <u>RefrigerationX's obligation under this warranty is limited to a period of two (2) years from the date of original installation or twenty seven (27) months after shipment date from RefrigerationX, whichever occurs first. Any part, covered under this warranty, that is by <u>RefrigerationX to have been found defective within two (2) years of original installation or twenty seven (27) months after shipment date from manufacturer, whichever occurs first, is limited to the repair or replacement, including labor charges, of defective parts or assemblies. The labor warranty shall include standard straight time labor charges only and reasonable travel time, as determined by RefrigerationX. (*Installation in unstable, mobile, and enclosed area may not be considered as proper installation.)</u></u>

Additional Three-Year Compressor Warranty...

In addition to the two (2) year warranty stated above, RefrigerationX warrants its hermetically sealed compressor to be free from defects in both material and workmanship under normal and proper use and maintenance service for a period of three (3) additional years from the date of original installation, but not to exceed five (5) years and three(3) months after shipment from the manufacturer. Compressor determined by RefrigerationX to have been defective within this extended period will, at RefrigerationX's discretion, be either repaired or replaced with a compressor or compressor parts of similar design and capacity.

The three (3) year extended compressor warranty applies only to hermetically sealed parts of the compressor and does not apply to any other parts or components, including, but not limited to, cabinet, paint finish, temperature control, refrigerant, metering device, driers, motor starting equipment, fan assembly and/or other electrical components, etcetera.

R-290/R-600a Hydrocarbon Compressor Warranty...

The three-year compressor warranty detailed above will be void if the following procedure is not carefully adhered to:

1. This system may contain R290 refrigerant and polyol ester lubricant.

The polyol ester lubricant has rapid moisture absorbing qualities. If long exposure to the ambient conditions occur, the lubricant must be removed and replaced with new.

- 2. Drier replacement is very important and must be changed when a system is opened for servicing. Drier with XH-7 molecular sieve or better must be used.
- 3. Micron level vacuums must be achieved to ensure low moisture levels in the system. 500 microns or lower must be maintained.
- 4. Compressor must be obtained through RefrigerationX, unless otherwise specified in writing, through RefrigerationX's warranty department.
